The Centre for Global Higher Education is a cross-disciplinary social science research centre focused on research investigation into global, national and local higher education and its futures. It is a partnership of three UK and eight international universities, headquartered at the UCL Institute of Education, University of London. Current funding from all sources is £6.1 million over five years. There are 15 specific research projects as of 31 January 2016.

Paul Ashwin is Professor of Higher Education in the Department of Educational Research, Lancaster University. His research expertise is in curriculum, learning, teaching and assessment.

Claire Callender is Professor of Higher Education Studies at UCL Institute of Education and at Birkbeck, University of London. She focuses on student finances in higher education and related issues.

Vincent Carpentier is a Reader at UCL Institute of Education. His research focuses on the global and national political economy of higher education and the socio-economic history of higher education.

Jennifer Case is a Professor in the Department of Chemical Engineering at the University of Cape Town in South Africa. Her research focuses on the student experience of learning, mainly in STEM fields.

Bruce Chapman is Professor of Economics in the Crawford School of Public Policy at the Australian National University. He designed the first national system of income contingent student loans for tuition.

Lorraine Dearden is Professor of Economics at UCL Institute of Education. She is a quantitative educational researcher who specialises in evaluation methods, and linked administrative and survey data.

Emla Fitzsimons is Professor of Economics and Principal Investigator of the Millennium Cohort Study, at UCL Institute of Education. She focuses on human capital investment and development.

Francis Green is Professor of Work and Education Economics at UCL Institute of Education. His research focuses on skills, training, work quality and industrial relations issues.

Ellen Hazelkorn is a Policy Advisor to the Higher Education Authority (HEA) in Ireland, and Professor and Director, Higher Education Policy Research Unit (HEPRU) at the Dublin Institute of Technology.

Morag Henderson is a Senior Research Officer in the Centre for Longitudinal Studies at UCL Institute of Education. Her research focuses on explanations of educational inequality.

Futao Huang is a Professor at the Research Institute for Higher Education, Hiroshima University, Japan, focusing on internationalisation, the academic profession, and university and college curricula.

Diana Laurillard is Professor of Learning with Digital Technologies, London Knowledge Lab, UCL Institute of Education, focusing especially on large-scale online learning and digital course design tools.

Nian Cai Liu is Professor, Dean of the Graduate School of Education at Shanghai Jiao Tong University in China, and creator of the annual Academic Ranking of World Universities, operating since 2003.

William Locke is Reader in Higher Education Studies and Director of the Centre for Higher Education Studies at UCL Institute of Education, focusing on policy, management and governance.

Simon Marginson is CGHE Director, Professor of International Higher Education at UCL Institute of Education, and Joint Editor-in-Chief of *Higher Education*. He focuses on international and global higher education.

Jan McArthur is a Lecturer in the Department of Educational Research, Lancaster University. Her research focuses on the purposes of higher education.

Ka Ho Mok is Vice President and Chair Professor of Comparative Policy of Lingnan University in Hong Kong. He focuses on higher education policy and governance, and comparative development, especially in relation to China and Asia.

Gareth Parry is Professor and Director of the Centre for the Study of Higher Education at the University of Sheffield. He focuses on system change and policy reform in tertiary education.

Peter Scott is Professor of Higher Education Studies at UCL Institute of Education. He focuses on the evolution of mass higher education systems, knowledge production and university governance and management.

Michael Shattock is a Visiting Professor at UCL Institute of Education, and the former Registrar of Warwick University. He is the founder of the IOE's MBA program in Higher Education Management.

Robert Tijssen is Professor of Science and Innovation Studies at Leiden University, Netherlands. He works at the intersection between science, innovation and higher education, and on the Leiden Ranking.

Celia Whitchurch is a Senior Lecturer at UCL Institute of Education. Her research includes the roles and identities of academic and professional staff, HRM and staffing models.

Gill Wyness is a Lecturer in Economics at UCL Institute of Education where her main interest is in quantitative research on higher education.
